Duration of course - **2 (two) years.**

Eligibility for admission to the course of M.Phil in Clinical Psychology :

Minimum educational requirement for admission to this course will be full time, regular M.A./ M.Sc. degree in the subject of Psychology of a recognized University with a minimum of 55% marks in aggregate, preferably with special paper in Clinical Psychology. For SC/ST/OBC category, minimum of 50% marks in aggregate, is essential. Candidates with M.A./ M.Sc. degree by correspondence course, Part-time course or by distance education are not eligible.

Prescribed application forms can be obtained from the office of the Director, Regional Institute of Medical Sciences, Imphal by paying a sum of Rs. 1000/- (Rupees one thousand) only for General/OBC and Rs. 800/- (Rupees eight hundred) only for SC/ST in the form of Bank Demand Draft drawn in favour of Director, Regional Institute of Medical Sciences, Imphal from a nationalize bank payable at Imphal.
