No.RIMS/184-Adms(PG)/2015 : This is for general information of the intending medical graduates of the beneficiary States of Regional Institute of Medical Sciences, Imphal and Non- RIMS medical graduates who are seeking admission to Postgraduate Courses in RIMS that the allocation of seats for MD/MS/Diploma Courses – 2015 and procedures of selection of candidates shall be as follows :

1. Reservation of PG seats in RIMS, Imphal :

- a) All India Quota (AIQ) : 50%.
- b) Beneficiary States including Non - RIMS medical graduates 50% seats are allotted as under :
 - (i) **Sponsored Category seats for the beneficiary States :**
(Arunachal Pradesh -7 , Manipur -7, Meghalaya - 7, Mizoram -7, Nagaland -7 , Sikkim -7 & Tripura -7).
 - (ii) **Open Category seats for RIMS graduates:**
(Arunachal Pradesh -2, Manipur – 02, Meghalaya – 02, Mizoram – 02, Nagaland – 02, Sikkim – 02, Tripura – 02 & RIMS (AIQ)- 2)
 - (iii) **Non-RIMS Medical graduates – 5 (from N.E region except Assam)**

2. Selection of candidates through AIPGMEE-2015 :

- a) AIQ seats to be filled in at All India Level as per norm adopted by DGHS(ME), Govt. of India from All India Merit List of AIPGMEE -2015.
- b) Beneficiary States seats (both sponsored and Open categories) will be allotted to eligible candidates through physical counselling to be held at RIMS, Imphal from the State-wise merit list of AIPGMEE -2015. .
- c) Non-RIMS Medical graduates shall be selected on the basis of merit list in AIPGMEE -2015.

3. The tentative date of counselling is 18/03/2015.

4. Application Forms :

Application forms in prescribed format and duly forwarded by the competent authority of the beneficiary states for sponsored, RIMS open category and non RIMS category of seats in RIMS are to be submitted to the office of the Director, Regional Institute of Medical Sciences, Imphal, Manipur. The application should accompany a Demand Draft of Rs.1000/- (Rupees one thousand only) for all category candidates from any nationalized bank of India (except UBI,RIMS Branch) drawn in favour of Director, Regional Institute of Medical Sciences, Imphal payable at Imphal. **The application form can be obtained from the Academic Section, RIMS, Imphal on payment of Rs.100/- or can be downloaded from the RIMS website, (www.rims.edu.in) from 08/12/2014 onwards.**

The last date of receiving application forms is 21st February, 2015. No candidate will be considered for admission to RIMS against sponsored/open category of seat unless he/she applies for PG seat and the concerned authorities have forwarded his/her application form within the stipulated date.
