## TERMS AND CONDITIONS FOR BUS

1. The tenderer should be the owner of a good condition bus. A Photo copy of the valid RC book duly attested by gazette officer should be submitted along with the completed tender form.
2. The bus must be one registered in the name of the tenderer.
3. Ownership document cannot be substituted by the documents like affidavit, Power of Attorney.
4. The vehicle must be a good condition one and to the satisfactory of the authority.
5. The bus must have to 40 to 50 seating capacity.
6. Fuel (either diesel or petrol) shall be provided by the owner of the bus.
7. Repairing and maintenance shall be at the cost of the bus owner/tenderer.
8. Driver and the handyman/ conductor shall be provided by the owner/tenderer.
9. Credentials, if any, should be supported by attested Photo copies.
10. The bus must be parked at the place identified by RIMS authority.
11. The owner/tenderer shall enter into a deed/agreement renewable for every 11 months.





## TERMS AND CONDITIONS FOR MARUTI VAN

1. The tenderer should be the owner of good condition Maruti van. A Photo copy of the valid RC book duly attested by gazette officer should be submitted along with the completed tender form.
2. The van must be one registered in the name of the tenderer.
3. Ownership document cannot be substituted by the documents like affidavit, Power of Attorney.
4. The vehicle must be a good condition one and to the satisfactory of the authority.
5. The van must have 4/7 seating capacity.
6. Fuel (either diesel or petrol) shall be provided by the owner of the van.
7. Repairing and maintenance shall be at the cost of the van owner/tenderer.
8. Driver shall be provided by the owner/tenderer.
9. Credentials, if any, should be supported by attested Photo copies.
10. The van is for use at RHTC, Bishnupur and must be parked at RHTC Bishnupur or at the place identified by RIMS authority.
11. The owner/tenderer shall enter into a deed/agreement renewable for every 11 months.

### **SERVICE TO BE PROVIDED**

1. Service	Provision of registered vehicle with licensed driver on hiring basis for running in Manipur state.
2. Period	Under normal circumstances, the contract shall be valid for a period of 1 year from the contract date of issue of work order. However contract may be extended for a further period upto 3years if agreed by the contractor and RIMS, Imphal on the same rate, terms and conditions after ensuing competitiveness of the rates.
3. Duty Hours	8 hrs per day and all days of month except Sundays and holidays. However, actual hours to be deployed shall be specified by users of the vehicles.
4. Reporting Place	Actual place of reporting shall be specified by users of the vehicles.
5. Counting distance	From garage to garage but chargeable distance in this respect shall not be more than 5 kms in each way.
6. Accuracy of metres	The meter reading should tally the actual distance of run. At any instant an authorized officer shall have full power to check up the meter for its correctness and to take action accordingly.
7. Penalties	In case of breakdown or any eventuality of vehicles, it has to be replaced by another vehicle immediately. In case of unavailability of vehicles, a penalty of Rs. 200/- per day may be imposed in addition to deduction on pro-rata basis for the period. If the number of breakdowns exceeds 3 times a month, a penalty of Rs. 300 per breakdown shall be imposed.
8. Others	a) Payment of state/central Government tax or duty for plying the vehicle in Manipur state will be liability of the contractor. b) Parking and toll charge, if any, may be claimed by producing valid parking/toll slips.
