No.2/18/13-CWS/RIMS :- The Director, Regional Institute of Medical Sciences, Imphal invites sealed item rate tender(s) in two-bid system (Technical Bid and Price Bid) from reputed, established and financially sound parties for the work(s) given below :-

The tender(s) should strictly adhere to the following terms and conditions :-

- 1 The tenderers should have completed minimum three works of similar nature of minimum value of Rs.20 lakhs each or two works of value Rs.25 lakhs each or one work of Rs.40 lakhs in their name during the last 5 years.
- 2 While applying for the tender document, the intending tenderers shall furnish proof of, experience certificates, works completed/awarded, sales tax/VAT/TIN as applicable.
- 3 Tenderers should have PAN Card
- 4 The earnest money deposit should be in the form of either D.D. or Banker Cheque from a Nationalised Bank in favour of the Director, RIMS, Imphal payable at Imphal.
- 5 The tender(s) complete in all respects should be submitted along with Earnest Money as stipulated in the Notice / Letter inviting Tender. Tenders without Earnest Money Deposit will be outrightly rejected.

Tenders should be submitted in Two separate sealed envelopes containing two parts as detailed below :

i) Technical Bid :-

This envelope shall contain the following :- EMD, details of completed works during the last 5 years along with proof of the same, Valid registration with Sales Tax department for Work Contract Tax/VAT/TIN. Copy of PAN Card should also be enclosed.

ii) Price Bid :-

This envelope shall contain the tender documents with **prices and amount duly filled by the party against each item prescribed in the schedule of quantity of the tender document.**

Both the sealed envelopes should then be put in one outer cover indicating thereon Name of work, Tender No., Due date & time of opening. The tender should be addressed to "The Director, Regional Institute of Medical Sciences, Imphal".

- 6 The tenderers desirous of supplying High Mast with different specifications/physical parameters can also quote. However, tenderers desirous to supply high mast of different specification than those mentioned in the tender document, should submit complete specification of the high mast, which they propose to supply against this tender during Prebid Meeting.
- 7 The last date of purchasing of the Tender form(s) is **28th January 2014.**

- 8 The tender(s) shall be received on or before **10th Feb. 2014** upto 3-30 p.m. and shall be opened (Technical Bid only) on the **11th Feb. 2014** at 4p.m. in presence of the Tenderer(s).
- 9 The cost of tender forms shall be paid in cash to the Cashier, RIMS.
- 10 The tender form(s) along with the Schedule of Quantity (ies) may be obtained from **the Central Workshop (Electrical div.), RIMS, Imphal** on production of the receipt issued by the Cashier or can be downloaded from the RIMS web site www.rims.edu.in. Those contractors who download the documents from the RIMS web site should, at the time of submitting the tender documents include the cost of the tender form in the form of either DD or Banker Cheque from a nationalised bank payable to "**the Director, RIMS, Imphal**".
- 11 **Pre-Bid Meeting:** Tenderers to please note that Pre-Bid meeting will be held in the conference hall of the Director, RIMS on **04th Feb.2014 at 3 p.m.** wherein all the clarifications with regard to Technical/Commercial conditions shall be given. Tenderers to also note that after clarifications given in the Pre-Bid meeting, no further deviation shall be permitted. Any differences in technical specification of high mast from that of contained in the tender documents should be brought out in the pre-bid meeting. The prebid meeting minutes will be communicated to all tenderers. Tender downloading should be done in the name of the company intending to quote for tender after registration of company in website www.rims.edu.in. Tenders downloaded in any other company name other than the one quoting will not be considered.
- 12 **Original verification of Documents:** Tenderers shall bring their original documents for verification on **16th Feb. 2014 from 10 hrs to 17 hrs**. No separate communication will be sent to tenderers for verification of original document. Tenderers who do not bring their original documents for verifications as per dates given above are liable to be disqualified.
- 13 The owner shall provide 415V, 3 Phase and Neutral power supply at the bottom of each mast by 3.5 core, 50mm2 XLPE armoured cable. Suitable flame proof (FLP) arrangement for receiving this cable shall be provided by the vendor.
- 14 The undersigned reserves the right to accept or reject any of the tender(s) without assigning any reason thereof.


