**Minimum Qualification** :

- 1) HSSC or its equivalent from a recognized university/board/council.
- 2) Certificate/Diploma in General Nursing & Midwifery from a recognised Institution or equivalent qualifications for Male Nurse.
- 3) Should be registered as 'A' Grade Nurse & Midwifery with a State Nursing Council or equivalent qualifications for Male Nurse.

**Age Limit** : Not exceeding 35 years as on 10/02/2014.

- 2) Relaxation of upper age limit by 5 years for SC/ST and 3 years for OBC candidates in respect of candidates who applied for the post reserved for these categories only.
- 3) Upper age limit is relaxable by 5 years for Govt. servants in accordance with instruction of Govt. of India.
- 4) Reservation of post for ST/SC/OBC will be as per the Govt. of India norms.
- 5) Persons working under the Central/State Govt./Public Sector undertaking/Autonomous organisations should submit their applications through proper channel. They may, however, send one advance copy of the application alongwith enclosures which should reach before the prescribed last date.

- 6) The applicants who do not have requisite qualifications and age limits on the last date of submission of applications will not be considered. The decision of the institute as to the eligibility or otherwise of a candidate will be final.

- 9) Mere fulfilling the minimum educational qualification doesn't bestow right to a candidate to be called for interview.
- 10) In case response to the post is large in number, a written test will be held in the concerned subject (GNM course) for screening.
