- d. The institute or the person may revoke the appointment or discontinue the engagement by giving 7 (seven) day notice in writing on either side.
- e. Director, RIMS, Imphal reserves the rights to terminate the engagement without giving any explanation or whatsoever with immediate effect without any remuneration or notice period on the ground of proven misconduct
