Terms and Conditions: -

1. Regional Institute of Medical Sciences, Imphal reserves the right to withdraw or cancel the auction if considered necessary without assigning any reasons.
2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
3. The bidders are required to deposit earnest money @ 10% of reserve price as shown above in the form of Demand Draft payable to the Medical Superintendent, RIMS, Imphal. The earnest money shall be returned to the unsuccessful bidder on completion of auction.
4. The successful bidder has to deposit 25% of the Bid Amount as 'Bid Security' in the form of Demand Draft payable to the Medical Superintendent, RIMS, Imphal, Manipur immediately on completion of the auction process. Balance of the sale value bid shall be paid by him in the form of Demand Draft payable to the Medical Superintendent, RIMS, Imphal within 5 days of issue of acceptance letter.  
In case of bidder's failure to deposit the bid security @ 25% of his bid money within the prescribed time (ie within one working day of closing of auction) his earnest money shall stand forfeited. In case of failure to deposit the balance of sale value within 5 days of issue of acceptance letter, the earnest money and bid security @ 25 % of his bid money shall be forfeited.  
In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (i.e. 2<sup>nd</sup> highest bidder) to complete the bid provided he/ she is prepared to accept the price offered by the highest tenderer. In case of any dispute, decision of the Medical Superintendent, RIMS, Imphal shall be final.

6. The offer through sealed tender in prescribed format addressed to Medical Superintendent, RIMS, Imphal, Manipur should reach this office or to be dropped in the 'Tender Box' of Disposal available at the site of auction. Tenders received after due date will be summarily rejected.
