No.RIMS/184-Adms(PG)/2019: This is for general information of the intending RIMS and Non-RIMS medical graduates (from N.E region except Assam) who are interested in admission to Postgraduate Courses in Regional Institute of Medical Sciences, Imphal that the allocation of seats for MD/MS/Diploma Courses for the academic year 2019 and procedures of selection of candidates shall be as follows:

- Reservation of PG seats in RIMS, Imphal:
 - a) All India Quota (AIQ): 50%.
 - b) Beneficiary States including Non RIMS medical graduates (50%) seats are allotted as under:
 - (i) Sponsored Category seats for participating States: (Arunachal Pradesh -7, Manipur -7, Meghalaya - 7, Mizoram -7, Nagaland -7, Sikkim -7 & Tripura -7).
 - (ii) Open Category seats for RIMS graduates: (Arunachal Pradesh -02, Manipur – 02, Meghalaya – 02, Mizoram – 02, Nagaland – 02, Sikkim -02, Tripura -02 and RIMS (AIQ) -02
 - (iii) Non-RIMS Medical graduates 05 (from N.E region except Assam)
- 2. Selection of candidates based on NEET-PG 2019 score :
 - a) AIQ seats are to be filled up at All India Level as per norm adopted by DGHS(ME), Govt. of India from All India Merit List of NEET-PG -2019.
 - b) Beneficiary States seats (both Sponsored and Open categories) will be allotted to eligible candidates through physical counselling to be held at RIMS, Imphal from the State-wise merit list of NEET-PG-2019.
 - c) Non-RIMS Medical graduates shall be selected on the basis of merit list in NEET -PG-2019.
- The tentative date of counselling is 10/04/2019.

4. Application Forms & Bulletin:

Application forms in prescribed format and duly forwarded by the competent authority (if employed) of the beneficiary states for sponsored, RIMS open category and non RIMS category of seats in RIMS are to be submitted to the office of the Director, Regional Institute of Medical Sciences, Imphal, Manipur. The application should accompany a Demand Draft of Rs. 2000/- (Rupees two thousand only) for all category of candidates from any nationalized bank of India (except UBI, RIMS Branch) drawn in favour of Director, Regional Institute of Medical Sciences, Imphal payable at Imphal. The application form can be obtained from the Academic Section, RIMS, Imphal on payment of Rs.100/-(Rupees one hundred) or can be downloaded from the RIMS website, (www.rims.edu.in).

The last date of receipt of application forms is 11th March, 2019. Application received after the last date of receipt of application will not be entertained. For sponsored candidates, applications must be submitted through proper channel and forwarded to the office of the Director, RIMS, Imphal within the stipulated date.
