No. B/3323/2019-RIMS: A major fire incident occurred in the College of Nursing, RIMS, Imphal on 17/4/2019. As a result Ladies Hostel No. 2 for College of Nursing was completely gutted to ashes by the fire. After the fire had been doused by the joint team of RIMS employees and Manipur Fire Services. A high level meeting chaired by Director, RIMS, Imphal was convened at 3:00 p.m. on the same day wherein a Disaster Response Team (DRT) was constituted under the chairmanship of Medical Superintendent, RIMSH, Imphal. Accordingly, a meeting of the DRT under the chairmanship of Medical Supdt., RIMSH was convened on 20/4/2019. The members of the DRT as a measure immediate relief inter-alia took a decision as under:

- a) After discussion the damage assessment report submitted by the Warden of the Nursing students hostels forwarded by the Principal of College of Nursing, the committee members agreed to make a payment of Rs. 35,000/- including purchase of new books exactly to each students totalling 68 students affected by the fire;
- b) It was unanimously agreed to voluntary pay one day salary of the month pay of April, 2019 for all the regular employees including PG/M.Ch students of RIMS in order to meet the urgent demands and necessity of the hostel of the College of Nursing, RIMS, Imphal

2. The donation will be voluntary and accordingly those staffs/students who do not wish to donate may intimate of the same by filling up the prescribed form which should be submitted on or before 3:00 p.m. of 29/4/2019 at the Receipt & Issue Counter of RIMS A-Block. The prescribed form is available at Receipt & Issue Counter of RIMS A-Block.

It is hereby circulated that those who are not willing to donate may submit the prescribed format at the Receipt & Issue Counter of RIMS A-Block on or before 3:00 p.m. of 29/4/2019.
