No.RIMS/184-Adms(PG)/2018: In partial modification of this office circular even No. dated 3rd May, 2018 and subsequent to the revised Cut-Off scores for NEET-PG 2018 vide public notification of NBE, New Delhi dated 27/04/2018, it is hereby informed to all the intending RIMS and Non-RIMS medical graduates who have newly become qualified as per NBE notification mentioned above and who are interested in admission to Postgraduate Courses in Regional Institute of Medical Sciences, Imphal to apply for the 2nd cum mop-up counseling.

The applications should accompany a Demand Draft of *Rs.2000/- (Rupees two thousand only)* for all category of candidates from any nationalized bank of India (except UBI,RIMS Branch) drawn in favour of Director, Regional Institute of Medical Sciences, Imphal payable at Imphal. The application forms can be obtained from the Academic Section, RIMS, Imphal on payment of Rs.100/-(Rupees one hundred) or can be downloaded from the RIMS website, (www.rims.edu.in) from 03/05/2018 onwards.

The last date of receipt of completed application forms is 10th May, 2018. Applications received after the last date of receipt of applications for both open and sponsored candidates due to any reason will not be entertained.
