

Any Indian national residing in the North Eastern States and holding MA/MSc degree in the subject of Psychology of a recognized University preferably with special paper in Clinical Psychology with a minimum of 55% marks in aggregate can apply. For SC/ST/OBC category, minimum of 50% marks in aggregate is essential. Candidates with MA/MSc degree through correspondence, part-time course or distance education programme are not eligible.
