Please find the features of the machine and our offer rate for the same.

1. It has a heating and ionising turbine - The turbine heats the air at 37 Degree C and ionises the air, then takes few droplets of Nocolyse (the disinfectant) and throws at a very high speed of 80 m/s. This ionised particles travels to every corner of the room and it sticks to all the surfaces thereby disinfecting them.

The normal fogging machines are just mist fans they make the liquid into a mist or wet fog which is heavy and cannot travel to every corner of the room.

2. It doesn't leave any residue

Usually the fogger machines leave a white/yellow residue which is harmful for the OT equipment and environment. Since there is no residue there is no corrosion and there is no resistance the germs create towards the disinfectant.

3. It sprays "dry fog"

There will be no moisture in the Operation Theatre after the spray.

The fogging machines result in moisture in the OT which is harmful for the equipment and humans working in those conditions.

4. It needs only 30 minutes of contact time. Therefore, it saves a lot of time and very useful between the surgeries, if need be.

Conventional fogging requires long closure times usually 3-4 hours.
