*No. C/78/MCI/33-RIMS/(Pt):* In pursuance of the Ministry of Health & Family Welfare, Government of India, O.M No . U-12025/13/2019-NE, dated 11<sup>th</sup> July 2019, the Regional Institute of Medical Sciences, Imphal will be implementing 10% reservation for Economically Weaker Section (EWS) in MBBS admission from the Academic Session 2019-20. For this purpose, the number of MBBS seats is increased from the existing 100 to 125 per annum from the Academic Session 2019-20. Out of the 25 seats increased, there will be 11 (eleven) seats for EWS, 10 (ten) Open seats (Unreserved Category) for candidates belonging to Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura and 4(four) seats for All India Quota (AIQ).

Accordingly, **online applications** for admission to MBBS for the Academic Session 2019-20 are hereby invited from intending candidates who belong to:-

- (i) EWS (who are not covered under the scheme of reservation for SCs, STs, and OBCs) and
- (ii) Open (UR)

**The candidates must be a domicile of NE states of Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura.**

***The last date of submission of online application at RIMS website ([www.rims.edu.in](http://www.rims.edu.in)) is 26-07-2019 upto 4.00 PM and Counselling will be done at RIMS, Imphal on 31-07-2019 at 10.00 a.m.***

The candidates shall be selected purely on the basis of merit list in NEET-UG-2019.
