- (2) The warranty period of the battery is 1 (one) year.
- (3) The cover of the rate quotation should be subscribe "Rate quotation for supply of "Rate quotations for supply of "Laminar Air Flow & 20° C Deep Freezer" for use of VRDL RIMS Imphal.
- (4) GST charges for the items should be mentioned clearly.
- (5) The rate tendered should be valid for one year from the due date of submitting the tenders.
- (6) Firm's GST No., Registration No., PAN No., etc.
- (7) The supplies should be made within 15 days from the date of placing supply order.
- (8) Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
- Earnest money Rs.5,000/-(Rupees five thousand) only along-with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal. 1. Laminar Air Flow

Specifications:

- a. Certification: EN12469 OR equivalent
- b. Design: Vertical laminar flow cabinet
- c. Approximately 4 Feet length X 2 feet depth, 304SS interior, epoxy/powder coated exterior Door fully closing with hinged sash.
- d. Support stand, solid one piece dished work surfaces
- e. Circulation: Down flow velocity of 40-70 fpm, ISO Class 5 or higher air
- f. Filters: HEPA filter, (99.99% efficient on particles 0.3 micron)/ULPA filter (efficiency of >99.999% at 0.1 to 0.3 micron sizes) provided with pre-filter)
- g. Light: UV and sufficient illumination for work space
- h. Gauges: For monitoring the condition of all HEPA filters as well as work space.
