Sub: Continuance of Recognition of MBBS degree (100 seats) in respect of Regional Institute of Medical Sciences, Imphal under Manipur University.

Sir/ Madam,

I am directed to inform that Compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Manipur University in respect of students being trained at Regional Institute of Medical Sciences, Imphal was carried out by the Council Assessors on 12<sup>th</sup> June, 2015. The compliance verification assessment report 12<sup>th</sup> June, 2015 alongwith the assessment report (Sept., 2014) was considered by the Executive Committee at its meeting held on 05.08.2015. The following recommendations of the Executive Committee approved by the General Body of the Council at its meeting held on 1st Oct., 2015 :-

*"The Executive Committee of the Council considered the compliance verification inspection report (12th June, 2015) along with previous assessment report (Sept., 2014) and decided to recommend that recognition of MBBS degree granted by Manipur University in respect of students being trained at Regional Institute of Medical Sciences, Imphal be continued restricting the number of admission to 100 (One Hundred) students."*

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout as stipulated in Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring the approval of Continuation of recognition by the Council and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage, your institution is liable not to be considered for approval of continuation of recognition with the annual intake capacity of 100 students and this approval is also liable to be revoked. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.


