





At the outset, the Medical Superintendent welcomed all the members present in the meeting. The meeting discussed on measles rubella vaccination campaign and reservation of dedicated beds in the medicine and paediatrics ward for any adverse event following immunization and agreed by the Heads of Departments of Medicine and Paediatrics that 2 beds in Paediatrics ward and 2 beds in the MICU from the medicine side are reserved and dedicated for AEFI. The allergic reaction following measles and rubella vaccination is rare but it may be mild to severe with life threatening conditions. Therefore the above dedicated beds are reserved to deal with the unlikely events.
