CPWD-6 for e-Tendering

1. **Item rate tenders** from firms/contractors registered with RIMS, Imphal for the following work: **Strengthening, widening of road from Radiotherapy junction to Gynae Ward and Staff Parking at Gynae OPD, RIMS, Imphal**
2. The enlistment of the contractors should be valid on the last date of sale of tenders. In case only the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.
3. The work is estimated to cost of Rs. 35,17,099/-This estimate, however, is given merely as a rough guide.
4. Agreement shall be drawn with the successful tenders on prescribed Form No.C.P.W.D.8 print edition 2012 (or other standard /Form as mentioned) as with up-to date amendments, which is available as a Govt. of India Publication. Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
5. The time allowed for carrying out the work will be six months from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
The site for the work would be available in phases.
6. Tender documents consisting of plans, specifications, the schedule of quantities of the various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen from website www.eprocure.gov.in or www.rims.edu.in free of cost. However, GCC available on from the 30.06.18 from www.rims.edu.in
7. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of tender as notified.
8. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of tender as notified.
9. When tenders are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the tender submitted earlier shall become invalid.
10. Tender Earnest money of Rs.70,342.00 in the form of Demand Draft or Pay Order or Banker's cheque or Deposit at Call Receipt or FDR (drawn in favour of Director RIMS, Imphal) of a Schedule Bank with validity of more than three month from the last date of submission of tenders, shall be scanned and uploaded along with other documents to the e-tendering website within the period of tender submission. The EMD and other documents (Which were uploaded during tender submission) shall be deposited physically by the lowest Bidders /Tender only within seven (7) days of opening of tender (status of being lowest to be checked by the bidder himself on line)
11. A part of earnest money is acceptable in the form of bank guarantee also, in such case, 50% of earnest money or Rs.20.00 lacs, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee.

12. Copy of Enlistment Order and certificates of work experience and other documents as specified in the press notice shall be scanned and uploaded to the e-tender website within the period of tender submission.
13. The contractor whose tender is accepted will be required to furnish performance guarantee of 5% (Five Percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of cash (in case guarantee amount is less than Rs. 10,000/-) or Deposit at call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank (in case guarantee amount is less than Rs. 1,00,000/-) or Government Securities of Fixed Deposit Receipts or Guarantee Bonds of any scheduled Bank or the State Bank of India in accordance with the prescribed form. Earnest money deposited along with tender shall be returned after receiving the afore said performance guarantee
14. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F', including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.
15. Intending tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstance which may influence or effect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderers shall be responsible for arranging and maintaining at his own cost all materials, tools and plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of tender by a tenderer implies that he has read this notice and all other contract documents has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plants etc., will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.
16. The competent authority on behalf of Director RIMS does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
17. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractor who resort to canvassing will be liable to rejection
18. The competent authority on behalf of Director RIMS reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
19. The contractor shall not be permitted to tender for works in the RIMS (Division in case of contractors of Horticulture/Nursery category) responsible for award and execution of contracts in which his near relative is posted as Divisional

Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Non-Gazetted officer in the RIMS. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.

20. No. Engineer of Gazette rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of One Month after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.
21. The tender for the works shall remain open for acceptance for a period of Sixty days (60) from the date of opening of tenders/sixty days from the date of opening of financial bid in case tenders are invited on 2/3 bid system (strike out as the case may be). If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenders shall not be allowed to participate in the re-tendering process of the work.
22. This Notice inviting tender shall form a part of the contract document. The successful Tenderer/Contractor, on acceptance of his tender by the Accepting Authority, shall, within 10 days from the stipulated date of start of the work, sign the contract consisting of:
 - (a) The notice inviting tender, all the documents including additional conditions, specifications and drawings, if any, forming part of the tender as uploaded at the time of invitation of tender and rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
 - (b) Standard C.P.W.D Form 8 (Print Edition 2010 with up-to date amendments & corrections)
