VIR/15/2018/ECD-I dated 14th March, 2019 from the Indian Council of Medical Research, Deptt. of Health Research, MoHFW, Govt. of India and as per letter no. 31/18/2019-M dated 20th May, 2019 from the Health & Family Welfare, Govt. of Manipur, that all research and surveillance studies conducted by private organizations or international partners that envisage collection of human specimens of any kind need to be reviewed by an authorized Government agency before implementation. The Indian Council of Medical Research (ICMR) has been designated as the Nodal Agency for reviewing and proving such proposals.

Hence, any private organization, international stakeholders, NGOs etc are not permitted to collect any kind of human sample from RIMS Hospital without prior approval from competent authority.


Subject: Not to permit any kind of human sample collection in the State by any private Organization, International stakeholders, NGO's etc without prior approval of ICMR.
