No. 3/Dy.DIr/RIMS-2019: In pursuance of Committee meeting held on 11<sup>th</sup> June, 2020 under the Chairmanship of Director, RIMS, Imphal with reference to completion of Final University Examination 2020 for those PG students who are admitted in 2017 and letter No. U-12021/44/2019-MEC dated 18/04/2020 of the Directorate General of Health Services, Govt. of India, the Competent Authority has approved to allow exercising of option for staying back by Clinical PG students for health care services in their respective department as well as duty detailing for Covid ward including Flu Clinic/Isolation Ward etc. in handling the Covid-19 pandemic.

- 2. Those PG students who opt to stay back shall be given full pay/stipend, Insurance cover (as per policy of the Central Government) and Certificate in acknowledgment of their contribution. The option shall be submitted to the Director, RIMS Imphal through Medical Superintendent, RIMS Hospital by 15<sup>th</sup> June, 2020. However, in case of withdrawal from their engagement after issue of order, 7 days' prior notice shall be given to the institute failing which appropriate disciplinary action including forfeiture of pay shall be initiated. Similarly, the engagement may be terminated by the Institute by giving 7 days' prior notice.
- 3. However, Postgraduate students who are leaving the institute in terms of notice No. A/187/PG(R)/RIMS/2015 dated 11<sup>th</sup> June, 2020 shall submit NOC from their respective Department, Library and Account Office etc. to the Dean(Academic), RIMS, Imphal.

4. This issues in partial modification of Academic Section's Order No. A/187/PG(R)/RIMS/2015 dated 11<sup>th</sup> June, 2020 and in consultation with Chief Accounts Officer & FA, RIMS, Imphal.
