
OFFICE MEMORANDUM

No. No. 662/NPS-CRA/2014-RIMS(Pt-II): It is observed that as on 30th June, 2019, 79 regular employees of the institute who joined on or after 1st January, 2004 have not yet opened their PRAN Account under National Pension System (NPS). In the absence of the respective PRAN Accounts, the subscription by the employee deducted from the salary and contribution from the employer towards the NPS Scheme are lying deposited with Axis Bank, the trustee bank of NPS, instead of getting credited in the individual PRAN Account maintained by NSDL.

In order to open their PRAN account, the employees need to submit the CSRF Form (Subscriber Registration Form). The CSRF form is available in the Pension & GPF Section, RIMS, Imphal or can be downloaded from the NPS website, https://ccaind.nic.in/pension_scheme/Subscriber_Registration_Form_CSRF.pdf. The list of employees who have not yet opened the PRAN Account is attached herewith as Annexure A, B and C. The concerned employees may contact Shri R.K Ranjit Singh in the Pension & GPF Section during office hours from 8th July to 17th July, 2019 for completing the formalities.
