I am directed to request you to kindly submit the rate quotation along with a copy of dealership/authorized stockiest/manufacturer authorization certificate, terms & conditions for "repairing and replacement of spare parts for 28 (twenty eight) nos. of GNATUS Dental Chairs and 11 (eleven) nos. of KAVO Dental chairs" installed at Dental College of RIMS, Imphal on or before upto 25/11/2019 up to 4.00 p.m.

The following details, terms and Conditions may please be furnished.

- (1) The price in words and figures should be indicated clearly.
- (2) The cover of the rate quotation should be subscribe " Repairing of Dental Chairs".
- (3) GST charges for the items should mentioned clearly.
- (4) The rate tendered should be valid for one year from the due date of submitting the tenders.
- (5) Firm's GST No., Registration No., PAN No., etc.
- (6) The supplies should be made within 30 days from the date of placing supply order.
- (7) Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
- (8) Earnest money Rs.10,000/- (Rupees ten thousand) only along-with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal. Interest on such Earnest Money will not be borne by us. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refundable after satisfactory completion of supplies. In the event of failure to supply the items with in the validity period and within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice.
- (9) The bidder should **provide AMC charges for each Dental Chairs for the next 3 (three) years** after 1 (one) year warranty period.
- (10) Price of each spare parts need to be replace should be mentioned clearly. The warranty for spare parts should be one year warranty period.
- (11) Late bidder i.e. received after last date of tender should not be consider.
