- (2) The cover of the rate quotation should be superscribed as "Single Bid" "Rate quotation for renovation of Histopathology Laboratory Furniture of Pathology Department, RIMS Hospital, Imphal".
- (3) The rate tendered should be valid for one year from the due date of submitting the tenders.
- (4) Firm's GST No., Registration No., PAN No., Non-Blacklist Certificate should be submitted.
- (5) Vendors should have local registered office and GST registration in Imphal, Manipur.
- (6) In the event of failure to complete the work within 30 days of the stipulated period, the successful bidder/supplier is liable to be blacklisted.
- (7) Earnest money Rs.15,000/-(Rupees fifteen thousand) only along-with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal.
