I am directed to request you to kindly submit the rate quotation along with a copy of dealership/authorized stocklest/manufacturer certificate, terms & conditions for supply and installation of 1 set OT light for use of RIMS Hospital, Imphal upto 23<sup>rd</sup> Dec 2019 up to 4.00 p.m.

## The following details, terms and Conditions may please be furnished.

- (1) The price in words and figures should be indicated clearly.
- (2) The warranty period of the machine is 5 (five) year from date of installation.
- (3) The cover of the rate quotation should be subscribe "Supply and installation of 1 set of OT light with accessories for use of RIMS Hospital, Imphal." The light should be USFDA/CE/BIS/ISO approved.
- (4) GST charges for the items should mentioned clearly.
- (5) The rate tendered should be valid for one year from the due date of submitting the tenders.
- (6) Firm's GST No., Registration No., PAN No., etc.
- (7) The supplies should be made within 30 days from the date of placing supply order.
- (8) Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
- (9) Earnest money Rs.10,000/-(Rupees ten thousand) only along-with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal. Interest on such Earnest Money will not be borne by us. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refundable after satisfactory completion of supplies. In the event of failure to supply the items with in the validity period and within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice.
- (10) Technical Specifications at annexure-A. Both price bid and technical bid should be enclosed at separate envelope at the time of submission.
- (11) The quotations/tender bids received after the last date will be not be considered.
- (12) Turn Over for last 3 (Three) years should be minimum of 1 crore, and ITR for last 3 years should be submitted.
