INVITATION OF RATE QUOTATION

Subject:- Submission of Rate Quotation (Two Bid) for supply consumable items for use of RIMS Hospital, Imphal.

Online Bids are invited on two bid system for supply of "Consumable items for use of RIMS Hospital, Imphal". Manual bids shall not be accepted. Earnest Money Deposit (EMD) should be submitted by post/courier/hand post. Tender documents and bidding may be submitted on or before ~~25th April~~, 2020 at CPP Portal website www.eprocure.gov.in

The following details, terms and Conditions may please be furnished.

- (1) The price in words and figures should be indicated clearly. GST rate for the items should be mentioned clearly.
- (2) The consumable items should be of well known manufacture/brand.
- (3) Bidder should be a manufacturer/authorized dealer/distributor/trader/supplier. Letter of authorization from manufacturer for the same and specific to the tender should be uploaded in prescribed place.
- (4) A brochure displaying clearly the product is to be attached with the tender if required.
- (5) The Manufacturer/Supplier should have local dealer/stockiest in Manipur, preferably at Imphal from whom the items are to be delivered to RIMS Imphal.
- (6) Vendors should have local registered office and GST registration in Imphal, Manipur.
- (7) The rate tendered should be valid for 1 (one) year from the date of submitting the tenders.
- (8) The envelope containing the EMD should be superscribed as **"Two Bid System" "EMD for supply of consumable items for use of RIMS Hospital, Imphal."**
- (10) Minimum 3 (three) samples each of the items should be submitted along with the EMD and should be enclosed at another seal cover.
- (11) Price Bid will be open only for those firm's who are qualified in Technical Bid and scrutiny of the samples.
- (12) Firm's photocopies of GST No., Registration No.(Certificate), PAN No., Annual turnover & audited balance sheet of last three year's, non-blacklist certificate should be submitted.
- (13) The supplies should be made within 30 days from the date of placing supply order.
- (14) Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
- (15) Earnest money Rs.50,000/-(Rupees fifty thousand) only along-with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal. Interest on such Earnest Money will not be borne by us. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refundable after satisfactory completion of supplies. In the event of failure to supply the items within the validity period and within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice.
