**The following details, terms and Conditions may please be furnished.**

- (1) The price in words and figures should be indicated clearly.
- (2) The warranty period of the machine is 1 (one) year.
- (3) The cover of the rate quotation should be subscribe "Rate quotation for supply of 4 (four) nos. of CTG machine for use of RIMS Hospital Imphal".
- (4) GST charges for the items should mentioned clearly.
- (5) The rate tendered should be valid for one year from the due date of submitting the tenders.
- (6) Firm's GST No., Registration No., PAN No. catalogue etc.
- (7) The supplies should be made within 30 days from the date of placing supply order.
- (8) Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
- (9) Earnest money Rs.5,000/- (Rupees five thousand) only along-with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal. Interest on such Earnest Money will not be borne by us. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refundable after satisfactory completion of supplies. In the event of failure to supply the items with in the validity period and within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice.

### **CARDIOTOCOGRAPHIC FOETAL MONITOR WITH MATERNAL FETAL MONITOR**

1. Standard size colour LCD/TFT screen monitor for display of waveforms and digital signals.
2. Automatic foetal movement detection facility in waveforms.
3. Standard twin pregnancy monitoring system.
4. Support for external thermal printer or inkjet printer.
5. Built –in rechargeable battery and AC/DC power supply.
6. Built –in net work capability.
7. 24 hours monitoring data storage and reload capacity.
8. Unit should have Fetal Heart Rate range of 50 to 240 beats/minute with Foetal heart acceleration and deceleration measurement ability
