## **NOTICE INVITING RE-TENDER**

Subject:- Invitation of Tender (Two Bid System) along with dealership/authorized Stockiest/ Manufacturer, certificate, terms and conditions for supply and installation of 3 nos. of 10 KVA Online UPS with Isolation Transformer and 1 hr backup batteries with suitable battery rack for use of RIMS Hospital, Imphal.

Sealed tender along with a copy of dealership/authorized stockiest/manufacturer certificate, terms & conditions for supply and installation of 3 nos. of 10 KVA Online UPS with Isolation Transformer and 1 hr backup batteries with suitable battery rack for use of RIMS Hospital, Imphal are invited on or before 27<sup>th</sup> May, 2020 upto 4.00 pm. Sealed Tender shall be opened on 28<sup>th</sup> May, 2020.

## The following details, terms and conditions may please be furnished.

- 1. The price in words and figures should be indicated clearly.
- 2. The warranty period of the item is 2 (two) year.
- 3. The cover of the rate quotation i.e. hard copy should be subscribed as (Two Bid System) "Supply and installation of 10 KVA Online UPS" for use of RIMS Hospital, Imphal.
- 4. GST charges for the items should mention clearly. Tender bid received after last date will not be considered. Bidder should be a manufacturer/authorized dealer/trade/ supplier. Letter of authorization from manufacturer for the same and specific to tender notice no. should be enclosed. Turnover and ITR for the last 1 year should be submitted.
- 5. The rate tendered should be valid for one year from the due date of submitting the tenders.
- 6. Firm's GST No., Registration No., PAN No., etc. Catalogue of the item should be enclosed.
- 7. The supplies should be made within 30 days from the date of placing supply order.
- 8. Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
- 9. The supplier should be register office along with GST Registration at Imphal.
- 10. Earnest money Rs. 15,000/-(Rupees fifteen thousand) only along with quotation should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS, payable at Imphal. Interest on such Earnest Money will not be borne by us. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refundable after satisfactory completion of supplies.
