- f) He/She is not permitted to communicate in press, radio broadcast, public utterance and telecast etc through any electronic media or in any document published in his/her own name or anonymously, pseudonymously or in the name of any other person. Failure to comply will attract Rule 9 of CCS (Conduct) Rules and the appointment shall be terminated forthwith.
- g) Any other residual conditions not specify in this order shall be governed by CCS (conduct) Rules 1964.
