ORDER Imphal, the 1st June, 2020

No.B/3026/2015/RIMS-IMPHAL: In view of unprecedented onslaught of pandemic Covid-19 as also opening of Trauma Care Centre (RIMS, Imphal), a Walk-In-Interview of those interested candidates willing to work in Covid cell of the institute was held on 29/05/2020 for engagement as daily worker. Based on the recommendation of the Selection Committee, the Competent Authority has approved the appointment of the following candidates to be deployed in VDRL/MDRU as Lab. Technician (skilled daily wagers) at the minimum wages rate of ₹ 593 per day as under:-

2. CONDITIONS ON APPOINTMENT:

- a) The candidate selected and appointed shall not be regarded as a member of the service to which he/she is appointed and shall not be entitled to have any preferential right for regular appointment.
- b) The institute or the person may revoke the appointment or discontinue the engagement by giving one month's notice in writing on either side.
- c) Director, RIMs, Imphal reserves the rights to terminate the engagement without giving any explanation or whatsoever with immediate effect without any remuneration or notice period on the ground of proven misconduct
- d) This appointment would automatically cease to operate on Lapse unless it is extended by the institute.
- e) No private Practice is allowed during the engagement period.
- f) All the recruited candidates shall maintain bonafide headquarters. Institute reserves the right to transfer the engaged employees to any other departments due to exigencies of work or administrative reasons.

- g) All persons appointed shall execute an agreement on a Non-Judicial Stamp Paper of Rs.100/- with two witnesses, and submit the same to the appointing authority concerned at the time of reporting for duty, agreeing to the terms and conditions of the engagement.
- h) Their engagement is purely temporary and on daily wage basis and it confers no right to claim contractual basis or regularization against regular post.
- i) During their engagement as daily wage worker, they will bound by the norms, rules and regulation of the institute and they will not be entitled to other service benefits of regular/contract employee.
- 1) They shall not participate in any form of agitation against the institute authority failing which their engagement will be terminated without any notice.
- 3. The selected candidate should join the institute immediately with attested copy of adhaar card, educational qualification, experience certificate, caste certificate etc. and submit it to the undersigned within 3 days failing which their selection will be cancel.
