No.3/Dy.Dir/RIMS-2019: Based on the Walk-in-Interview held on 16th June, 2020 and pursuant to the recommendation of the Selection Committee, the Competent Authority has approved the appointment of the following Doctors as Junior Resident (non-academic) for deployment in containing Covid-19 and in Trauma Care Centre (TCC) of RIMS, Imphal for a period 3 months from the date of joining in the pay Level 10 (initial pay of ₹56100/-) as per 7th CPC per month: -

- 2. Further, the appointment of Doctors as Junior Resident in the institute is subjected to the following terms and conditions:
  - a) No private practice during the appointment is allowed.
  - b) The selected candidates should join the institute within a period of 2 days from the date of issue of this order, failing which their appointment stands cancelled and waitlisted candidate shall be appointed.
  - c) If anyone is found practicing/working in any private Clinic/Hospital, the shall be terminated without prior notice.
  - d) Absence without prior sanction of the competent authority shall be liable for disciplinary action under Conduct Rules of the institute.
  - e) 7 days' prior notice should be given in case of resignation or else one month's salary shall be forfeited.
  - Redress of grievances/representation on service matter shall be seek through proper channel and in accordance with DoP&T O.M. No. 1101310812013-Estt (A)-III dated 6th June, 2013.

- g) Unauthorised communication in press, radio broadcast, public utterance and telecast etc through any electronic media or in any document published in his/her own name or anonymously, pseudonymously or in the name of any other person is highly prohibited during the appointment. Failure to comply will attract Rule 9 of CCS(Conduct) Rules and the appointment shall be terminated forthwith.
- h) The selected Doctors should join their respective departments within 3 days and failure to join within the stipulated time will entail immediate cancellation of the appointment
- Joining reports should be submitted to the undersigned. For those Doctors who have not given their permanent MMC Regd. No. should submit the registration number or under process certificate within one week from the notification.
- Any other residual conditions not specify in this order shall be governed by CCS(Conduct) Rules 1964.
