The following details, terms and Conditions may please be furnished.

- (1) The cover of the rate quotation should be subscribed "Single Bid System" for supply of Laser Jet Printer and All- in-one laser printer for use of RIMS, Imphal.
- (2) The equipments should be of well known manufacturer/Brand.
- (3) The price in words and figures should be indicated clearly. The brand of the product should also clearly be mentioned along with catalogue.
- (4) VAT Charges for the items, Firm's TIN No., Registration No., PAN No., non black list affidavit, Authorization Certificates etc.
- (5) The rate tendered should be valid for one year from the due dates of submission the tenders.
- (6) Earnest money Rs.3000/-(Rupees three thousand) only along with rate quotation should be submitted in the form of Bank Draft from any Nationalized Bank in favour of Director RIMS, payable at Imphal. Interest on such Earnest Money will not be borne by us. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refundable after satisfactory completion of supplies. In the event of failure to supply the items with in the validity period and within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice.
- (7) The supplies should be made within 30 days from the date of placing supply order.
