NOTICE INVITING TENDER

Subject:- Invitation of Tender (Two Bid System) for supply and installation of - 80°C Ultra Low Deep Freezer for use of RIMS, Imphal.

Sealed tender along with a copy of dealership/authorized stockiest/manufacturer certificate, terms & conditions for supply and installation of - 80°C Ultra Low Deep Freezer for use of RIMS, Imphal are invited on or before 31st August, 2020 upto 4.00 pm. Sealed Tender shall be opened on 1st September, 2020.

The following details, terms and conditions may please be furnished.

1. Bidders are required to submit Bid in one envelope (Superscribed : - 80°C Ultra Low Deep Freezer in RIMS, Imphal) in the name of The Director, RIMS, Imphal containing two separate envelopes for the Technical Bid and the Financial bid each.
2. The price in words and figures should be indicated clearly.
3. The warranty period of the item is 3 (three year).
4. GST charges for the items should mention clearly. Tender bid received after last date will not be considered. Bidder should be a manufacturer/authorized dealer/trade/ supplier. Letter of authorization from manufacturer for the same and specific to tender notice no. should be enclosed. Turnover and ITR for the last 1 year should be submitted.
5. The rate tendered should be valid for one year from the due date of submitting the tenders.
6. Firm's GST No., Registration No., PAN No., etc. Catalogue of the item should be enclosed.
7. The supplies should be made within 30 days from the date of placing supply order.
8. Failure to supply the items within the stipulated period and also within the validity period, the successful bidder/supplier is liable to be blacklisted.
9. Earnest Money Deposit (EMD) Rs. 15,000/- (Rupees fifteen thousand) only should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank in favour of Director RIMS payable at Imphal. Interest on such Earnest Money will not be borne by the institute. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refunded after satisfactory completion of the work. In the event of failure to complete the works within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice. **The EMD in the form of Bank Draft should be enclosed in the Envelope containing the Technical Bid.** The bid will be rejected if the EMD is enclosed in the envelope containing the Financial Bid.
10. The Institute reserves the right to accept or reject any/or all the offers without assigning any reason thereof, and Institute's decision shall be final.
11. Any further notifications/ corrigendum related to this tender will be published on RIMS website only and not elsewhere.
