



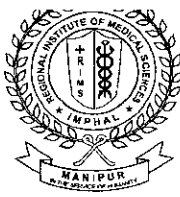

ANNEXURE-I

GENERAL TERMS AND CONDITIONS OF THE CONTRACT

- 1) Bidders are required to submit Bid in one envelope (Superscribed: Catering service in Quarantine Centres in RIMS, Imphal) in the name of The Director, RIMS, Imphal containing two separate envelopes for the Technical Bid and the Financial bid each. Annexure are to be filled as attached.
- 2) Earnest Money Deposit (EMD) Rs. 10,000/- (Rupees ten thousand) only should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank or money deposit receipt in favour of Director RIMS payable at Imphal. Interest on such Earnest Money will not be borne by the institute. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refunded after satisfactory completion of the work. In the event of failure to complete the works within the stipulated period from the date of placing supply order, the security Deposit shall be forfeited without any prior notice. **The EMD in the form of Bank Draft should be enclosed in the Envelope containing the Technical Bid.** The bid will be rejected if the EMD is enclosed in the envelope containing the Financial Bid.
- 3) The contractor having an establishment in Imphal and running a canteen or catering services or restaurant also may apply. Preference will be given to those who are already successfully running hotel/canteen/food plaza/restaurant in reputed organization/public place.
- 4) The contract shall initially be for a period of 6(six) months, which would be renewable for a further period depending on the Covid-19 quarantine centers of RIMS, Imphal. Subsequent extension of service beyond the initial period is on mutual agreement and other criteria as determined and settled mutually.
- 5) The contract is to prepare and serve standard items of snacks, lunch, tea and other beverages to the said Quarantine Centres of RIMS, Imphal. The food and beverages provided should be of good quality and freshly prepared with fresh ingredients.
- 6) The quantity of meals to be provided per day will vary and will depend on the number of inmates in the quarantine centres of RIMS, Imphal.
- 7) Any revision in rates will be considered only at the time of renewal of the annual contract by mutual agreement taking into consideration the market/inflation rates.
- 8) Based on the suitability of offers, price bid will be opened only from those parties who fulfill the pre-qualification criteria and eligibility conditions submitted by the bidder in the technical bid. Merely quoting of lowest price does not entail the bidder for award of the contract. The price should be justified in accordance with the prevailing market rate, quality of service in question and as such the Tender Committee's decision shall be binding on the bidders.
- 9) Unrealistic rates/quotation shall be rejected outrightly.

- 10) Bids will be evaluated on all the eligibility parameters and a short-list of eligible caterers qualified in the technical bid will be drawn. After evaluating the price-bids from the eligible short-listed caterers, the Institute shall award the final Contract to the bidder with the lowest price offer for carrying out the catering services at RIMS, Imphal. Considering the importance and nature of the work i.e. providing of food to persons at the RIMS Quarantine centres uninterruptedly, in the event of unrealistic rates (i.e. abnormally low or abnormally high rates) quoted by the bidders bids of such bidders will be rejected and award of the work without call of fresh tender will be considered from the remaining bidders.
- 11) The bidder must have an experience of at least 1 year as on 30<sup>th</sup> April, 2021 in successfully running of catering service (Copy of implementation/service to be enclosed).
- 12) The Caterer shall provide disposable containers/items for serving the food and shall also ensure that the disposable food plate, breakfast container/disposable spoons, disposable cum and paper napkins in which food and beverages are served are new, clean and having food grade quality.
- 13) The Institute has the right to levy penalty and even terminate the contract if there is deterioration in any kind of services, quality of food stuff, material, hygiene, etc. In case of any dispute in this regard, the decision of the Institute will be final and binding
- 14) The contractor shall not engage any agent or enter into sub-contract with any other caterer(s) for running the said service.
- 15) The Institute reserves the right to accept or reject any/or all the offers without assigning any reason thereof, and Institute's decision shall be final.
- 16) Either party shall terminate this contract by giving one month notice in advance to the other party.
- 17) The contractor/vendor shall provide to his cooking and serving staff appropriate dresses/uniforms, aprons, gloves, white chef's head cap or equivalent to protect hairfall into the food items etc.
- 18) The successful contractor shall indemnify the institute from any claim by its staff/employees arising from the contract.
- 19) The bidder(s) is to put their signatures at each relevant pages of the tender document during submission of their bid. The bidder may attach relevant extra sheets wherever required duly self-certified.
- 20) Any further notifications/ corrigendum related to this tender will be published on RIMS website only and not elsewhere.

- iv. Details of Organizations/Institutions/Public Place where the vendor has provided/providing the canteens services
- v. GST registration number
- vi. PAN Card
- vii. Valid and applicable FSSAI license certificate
- viii. Any other certificates as found relevant by the bidder

  - ✓ Minimum number of 4(four) varieties of Dals i.e. Masoor, Arhar, Kangtak and Moong shall be provided in such a manner that each type of Dal is provided at least in 2(two) meals in a week i.e. 2 meals out of 14 meals in a week i.e. 8 prescribed varieties of Dals in 14 meals and 6 remaining weeks may be other Dals or repeat of the above mentioned 4 varieties.
