**COUNSELLING FOR MBBS ADMISSION 2021 FOR NE-OPEN (UR)**  
**AND NE-EWS CATEGORY SEATS**

**To be held on March 1, 2022 (Tuesday)**

Candidates must be bonafide Domicile/Permanent Resident Certificate holders of NE States (Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura).

The following NE-Open (UR) NE-EWS and candidates (Annexure A & B) are called for the counselling to be held on *March 1, 2022* at the Jubilee Hall, RIMS, Imphal.

The candidates, who are called for counselling, have to report in person at the above venue and date at *9.00 A.M.* Candidates must produce the following certificates in **original** at the time of counselling.

1. Domicile Certificate (From the competent authority only) from their respective states.
2. NEET-UG-2021 score card
3. Pass Certificate of the qualifying examination (10+2 standard)
4. Mark sheet of qualifying examination (10+2 standard)
5. Age Proof Certificate showing the date of Birth (Class X Certificate or Birth Certificate)
6. 3 (three) recent (passport size color photographs)
7. Admit Card of NEET-UG 2021 conducted by NTA, New Delhi.
8. Candidates applying in EWS Category, **Original EWS certificate issued by the competent authority**

During the counselling, after verification of documents and ascertaining the eligibility, the seats will be allocated to the candidates purely on the basis of the NEET-UG-2021 merit (rank) till all the seats are filled in.

Candidates, who fail to attend the counselling on the notified date, shall forfeit their claims for admission and placement in the wait list. The candidates will also have to deposit the fees by bank challan of PNB, RIMS, Imphal (no cash payment will be entertained) after a seat is allotted to him/her on the day of the counselling.

It may be noted that mere calling for the counselling does not mean allotment of a seat to a candidate. The Counselling Committee reserves the right to fill or keep any number of seats vacant.

*Note:* If any of the original certificates listed above is found to be fabricated/false, eligibility for counselling/admission will be forfeited. If the certificates are found in any other language except English, a copy of English translation attested by a Gazetted Officer should be produced. Any discrepancy in the published list of the eligible candidates may be reported to the Dean's Office at least 24 hours before the counselling.

The decision of the Counselling Committee shall be the final and binding to all. If the seats are not filled up in this counselling, vacant seats will be filled up from the wait listed candidates.

*Those coming from outside Manipur should fulfil the requirements for travelling to Manipur issued by the Govt. of Manipur from time to time.*
