No.RIMS/184-Adms(PG)/2020 : This is for general information of the intending RIMS and Non-RIMS medical graduates (from N.E region except Assam) who are interested to undergo Postgraduate Courses in Regional Institute of Medical Sciences, Imphal, that the allocation of seats for MD/MS/Diploma Courses for the academic year 2020 and procedures of selection of candidates shall be as follows :

1. **Reservation of PG seats in RIMS, Imphal of the total 147 seats, 50% seats will be allotted to AIQ and remaining 50% seats will be distributed among other categories as follows:**
 - A) **All India Quota (AIQ) : 50% (73 seats)**
 - B) **Sponsored (Beneficiary States of RIMS)**
(Arunachal Pradesh -8, Manipur -8, Meghalaya - 7, Mizoram -7, Nagaland -7, Sikkim -8 & Tripura -8).
 - C) **Open Category :**
 - i) **RIMS Graduates - 14** (Arunachal Pradesh -02, Manipur – 02, Meghalaya – 02, Mizoram – 02, Nagaland – 02, Sikkim – 02, Tripura – 02
 - ii) **RIMS AIQ Graduates – 02**
 - D) **Non-RIMS NE graduates – 05** (from N.E region except Assam)
2. **Selection of candidates based on NEET-PG – 2020 score:**
 - a) AIQ seats are to be filled up at All India Level as per norm adopted by DGHS (ME), Govt. of India from All India Merit List of NEET-PG -2020.
 - b) Beneficiary States seats (both Sponsored and Open categories) will be allotted to eligible candidates through physical counselling to be held at RIMS, Imphal from the State-wise merit list of NEET-PG-2020.
 - c) Non-RIMS Medical graduates shall be selected on the basis of merit list in NEET–PG–2020.
3. **The tentative date of counselling is April 16, 2020.**
4. **Application Forms & Bulletin:**

Duly filled in application forms in prescribed format should be submitted to the Director, Regional Institute of Medical Sciences, Imphal, Manipur within the stipulated time. For sponsored (government employed) candidates, the applications should be forwarded by the competent authority (if employed) of the beneficiary states. A Demand Draft of **Rs.2000/- (Rupees two thousand only)** from any nationalized bank of India (except UBI,RIMS Branch) drawn in favour of the Director, Regional Institute of Medical Sciences, Imphal payable at Imphal should be deposited along with the application form. The application forms can be obtained from the Academic Section, RIMS, Imphal on payment of Rs.100/-(Rupees one hundred) or can be downloaded from the RIMS website, (www.rims.edu.in).

The last date of receipt of duly filled in application forms is **March 13, 2020**. Applications received after the last date will not be entertained.
