No.RIMS/184-Adms(PG)/2014 : This is for general information of the intending medical graduates of the beneficiary States of Regional Institute of Medical Sciences, Imphal seeking admission to Postgraduate Courses in RIMS that the allocation of seats for MD/MS/Diploma Courses – 2014 and procedures of selection of candidates shall be as follows :

1. Reservation of PG seats in RIMS, Imphal :

- a) All India Quota (AIQ) : 50% seats are reserved for AIQ
- b) Beneficiary States including RIMS employee : 50% seats are open to beneficiary States as under :
 - (i) **Sponsored Category seats for the beneficiary States & RIMS Employee :**
(Arunachal Pradesh – 8, Manipur – 8, Meghalaya – 8, Mizoram – 8, Nagaland – 8, Sikkim – 8, Tripura – 8 & RIMS Employees – 3)
 - (ii) **Open Category seats for RIMS graduates : 14 Nos.**
(Arunachal Pradesh – 02, Manipur – 02, Meghalaya – 02, Mizoram – 02, Nagaland – 02, Sikkim – 02, & Tripura – 02)


2. Selection of candidates through AIPGMEE-2014 :

- a) AIQ seats to be filled in at All India Level as per norm adopted by DGHS(ME), Govt. of India from All India Merit List of AIPGMEE -2014.
- b) Beneficiary States seats (both sponsored and Open categories) will be allotted to eligible candidates through physical counselling to be held at RIMS, Imphal from the State-wise merit list of AIPGMEE -2014. The tentative date of counselling is **4th March, 2014**.
- c) RIMS Employees shall be selected on the basis of merit in AIPGMEE -2014 of any of the beneficiary States of RIMS.

Application Forms :

Application forms in prescribed format and duly forwarded by the concerned authority of the beneficiary States/RIMS for sponsored and RIMS open category of seats in RIMS to be submitted to the office of the Director, Regional Institute of Medical Sciences, Imphal, Manipur. The application should accompany a Demand Draft of Rs.500.00 (Rupees five hundred only) for UR & OBC candidates and Rs.400.00 (Rupees four hundred only) for ST & SC candidates from any nationalized bank of India (except UBI,RIMS Branch) to be drawn in favour of Director, Regional Institute of Medical Sciences, Imphal payable at Imphal. **The application form can be obtained from the Academic Section, RIMS, Imphal or can be downloaded from the RIMS website, (www.rims.edu.in) from 20/ 01/2014 onwards.**

The last date of receiving application forms is **14th February, 2014**. No candidate will be considered for admission to RIMS against sponsored/open category of seat unless he/she applies for PG seat and the concerned authorities have forwarded his/her application form within the stipulated date.
