- i) Postgraduate degree or diploma in the respective broad speciality (MD in Medicine or MS in Surgery or Diploma or equivalent qualification) recognized by MCI after obtaining a medical qualification included in the Schedule I & II of the 3<sup>rd</sup> Schedule of Indian Medical Council Act 1956 (persons possessing qualifications included in the part II of the 3<sup>rd</sup> Schedule should also fulfill the conditions specified in section 13 (B) of the Act).
- ii) Satisfactory completion of the compulsory internship in a recognized hospital.
- iii) Candidate must be registered with the State Medical Council/Medical Council of India.
