**No. B/1256/13-RIMS:** Regional Institute of Medical Sciences, Imphal invites application from the citizens of India who possess the under-mentioned qualifications and experiences for recruitment of 1(one) Medical Superintendent, RIMS Hospital, Imphal on regular basis in the scale of Rs. 37,400 - 67,000 + G.P. Rs. 10,000/- plus N.P.A. and other allowances as admissible under the Society's Rules. Intending candidates may submit their applications for the post so as to reach office of the undersigned on or before 8<sup>th</sup> February, 2013. Candidates serving under state Govt./Central Govt./Autonomous Organization may submit their applications through proper channel. Those candidates who have applied for the post of Medical Superintendent, RIMS Hospital in response to the advertisement of even number dated 16<sup>th</sup> July, 2011 need not submit fresh application for the post. They however, may update their biodata by submission of a fresh biodata and certificate in support of the updates if they desire to do so.

**1. Qualification:-**

- a) MBBS Degree and registered under Indian Medical Council Act or any other act or B.D.S. registered under Indian Dental Council.
- b) Post Graduate Qualification i.e. M.D./M.S./M.D.S. or a recognized qualification equivalent thereto in any Medical/Dental discipline.

OR

Master's Degree in Hospital Administration from a recognized Institution/University or a recognized qualification thereto.

**Experience:**

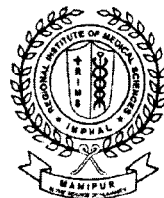
14 years teaching and/or research experience after obtaining the Post Graduate qualification in the specialty or Master's Degree in Hospital Administration of which, at least 7 years should be in the administration of a major Hospital in a senior position.

- 2. Age:-** Upper age limit is 55 (fifty-five) years. The upper age limit is relaxable by 5 years for Government servant/RIMS employees. The post of Medical Superintendent is full time resident and without clinical attachment. The upper age limit shall be reckoned on the last date of the receipt of the applications of the advertisement. The age of superannuation of Medical Superintendent is 62 years.

An applicant from among the employees of RIMS, Imphal will have the option to continue in teaching/clinical positions after attaining the age of 62 years, if he/she desires so.
