- (iii) Age relaxation Criteria:-

Note: No age relaxation would be available to OBC/SC/ST candidates as the posts are UR post.	

- (iv) Date of Birth, as recorded in the Matriculation/Secondary Examination Certificate only, will be accepted for determining the age and no subsequent request for change will be considered or granted.

3. Application Fees:-

- (a) A non-refundable application fee of Rs. 1000/- (Rupees One thousand only) shall be paid through online mode.
- (b) Application fee is exempted for PwD candidates.
- (c) Application fee, once remitted, shall not be refunded, unless the recruitment process is cancelled.
- (d) Applications without the prescribed fees would not be considered and will be summarily rejected.
