**RULES AND REGULATIONS OF M.PHIL.CLINICAL PSYCHOLOGY
ENTRANCE EXAMINATION FOR THE ACADEMIC SESSION – 2024**

1. **Six seats** of M.Phil. Clinical Psychology are available in the Department of Clinical Psychology, Regional Institute of Medical Sciences, Imphal, Manipur.
2. **Eligibility Criteria:**
 - The candidate must be an Indian National residing in the beneficiary states of RIMS - Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura, holding M.A./M.Sc. Psychology Degree from a recognized University.
 - M.A./M.Sc. Psychology Degree with 55% for General Candidates and 50% for other categories in aggregate from a recognized University preferably with a paper in Clinical Psychology.
 - M.A./M.Sc. Psychology Degree from Distance Education/ Correspondence / Part-time Course are not eligible.
3. **Duration of the Course:** The course will be for a duration of **2 (two) years** and the **session** will commence from **July 1, 2024**.
4. **Centre for Examination:** RIMS, Imphal.
5. **Application Forms & Submission:**
 - The prescribed application form may be downloaded from the institute's website – www.rims.edu.in. The duly filled out form may be submitted to the Dean (Academic), RIMS, Imphal or by email to dean.rims.imphal@gmail.com along with the proof of payment of a non-refundable fee of Rs. 2000 (Rupees Two thousand) at the time of submission of the form. Candidates may also collect the applications from the Academic Section, RIMS, Imphal on payment of fee of Rs.2000 (Rupees two thousand).

➤ **No candidate can enjoy double monetary benefit in terms of stipend.**

(i) **Admit Card:**

- Admit Card for appearing in the Entrance Examination will be issued to the eligible candidates from June 15, 2024.
- Admit cards should be collected from the Academic Section, RIMS, Imphal latest by 4.30 pm of June 20, 2024. No admit card will be dispatched by post.
- Candidates are advised to preserve the Admit Cards till allotment of seats.
- Duplicate Admit Card will not be issued after the examination.

(ii) **Examination:**

- There will be one paper of one and half hours duration containing 100 Multiple Choice Questions (MCQ) which will cover topics on General, Experimental & Clinically related subjects of Psychology.
- The questions will be single response objective type. Each answer with correct response shall be awarded one mark. No mark will be given for attempting more than one answer against a question or / and over writing, use of correction fluid. Unattempted question(s) is/are to be marked as cross (X) against the question number. There will be no negative marking for wrong answer.
- Examination hours: 11.00 A.M. to 12.30 P.M.
- The Examination shall be conducted in English medium only.

(iii) **Conduct of Examination:**

- Examination will be conducted in the Examination Hall of Regional Institute of Medical Sciences, Imphal on **23.06.2024 at 11.00 A.M.**
- Candidates should report at the Examination Hall at 10.40 A.M. Candidate reporting after 15 minutes of the commencement of the examination shall not be permitted to appear in the examination.
- A candidate who does not possess the Admit Card issued by the Institute shall not be allowed into the examination hall under any circumstances.
- No candidate shall be allowed to carry mobile phone, pages, calculator, book, printed or written pieces of paper, smart watches and devices, or any objectionable materials except the Admit Card inside the examination hall. Candidates found engaging in copying/ conversation or in possession of the above-mentioned restricted items shall be deemed to be disqualified for the entrance examination.
- Only ball pen should be used.

(iv) **Declaration of Results:**

- The result of successful candidates in order of merit, will be declared as soon as possible, most likely on the day of examination.

(v) **Inter-se-merit of candidates obtaining equal marks:**

In case of two or more candidates obtaining equal marks in the competitive entrance examination, the inter-se-merit of such candidates shall be determined in order of preference as follows:

- Candidate securing higher percentage of marks/Grades in the M.A./M.Sc. Examination
- Seniority, in case of in-service candidate
- According to age, older will get preference over younger

(vi) **Admission:**

At the time of admission, the candidates are required to pay the necessary fees, produce and deposit the following original documents to the Academic Section, RIMS, Imphal.

- i) X / HSLC Certificate & Mark Sheet
- ii) XII or equivalent Certificate & Mark Sheet
- iii) B.A./B.Sc. Certificate & Mark Sheet
- iv) M.A./M.Sc. Certificate & Mark Sheet

(vii) **Other Conditions:**

The original certificates deposited at the time of admission shall be retained in the Dean's Office till the end of the course. Once admitted, a candidate who leaves the M.Phil. Clinical Psychology course within a year of joining, shall be liable to pay a sum of Rs.1,00,000 (Rupees one lakh only) and any candidate who leaves after one year of joining shall be liable to pay a sum of Rs. 2,50,000 (Rupees two lakhs fifty only) by way of compensation/ losses incurred by RIMS, Imphal due to such midstream departure. Candidates getting stipend from RIMS are also liable to return the cumulated amount received from the RIMS, Imphal over and above the penalties mentioned above.

An undertaking to this effect shall be submitted in the prescribed format by the candidate at the time of admission.

(viii) **Jurisdiction:**

Any dispute arising thereof related to the selection and admission will be under the discretion of the Selection Committee, M.Phil. Clinical Psychology, RIMS, Imphal. Any legal disputes pertaining to the selection of candidates shall fall within the jurisdiction of Manipur High Court.
