ANNEXURE-I

GENERAL TERMS AND CONDITIONS OF THE CONTRACT: -

- i) Bidders are required to submit Bid in one envelope (Superscribed: EOI FOR EMPANELMENT AS OUDOOR CATERING SERVICE PROVIDER AT RIMS, IMPHAL) in the name of The Director, RIMS, Imphal, containing two separate envelopes for the Technical bid and Financial bid each. Annexure are to be filled as attached.
- ii) Earnest Money Deposit (EMD) Rs. 20,000/- (Rupees Twenty thousand only) should be submitted in the form of Bank Draft from any Nationalized Bank/schedule bank or money deposit receipt in favour of Director RIMS payable at Imphal. Interest on such Earnest Money will not be borne by the Institute. The earnest money of unsuccessful firm will be refunded on demand. For the successful bidder, it will be retained as security deposit which shall be refunded after satisfactory completion of the contract. In the event of failure to complete the works within the stipulated period from the date of placing supply order, the security deposit shall be forfeited without any prior notice. The EMD in the form of Bank Draft from any Nationalized Bank/schedule bank or money deposit receipt should be enclosed in the Envelope containing the Technical Bid. The bid will be rejected if the EMD is enclosed in the envelope containing the Financial Bid.
- iii) The firm having an establishment in Imphal and running a canteen or catering services or restaurant. Preference will be given to those who are already successfully running hotel/canteen/food plaza/restaurant in reputed organization/public place.
- iv) The empanelment shall initially be for a period of 1(one) year from the date of empanelment with provision for further extension of one-year subject to satisfactory performance. After reviewing the performance, the empanelment may be considered for renewal for a period as deemed suitable by the institute. In case of unsatisfactory performance/breach of terms, the hiring contract may be terminated with fifteen days' notice.
- v) The contract is to prepare and serve standard items of snacks, lunch, teach and other beverages. The food and beverages provided should be of good quality and freshly prepared with fresh ingredients. The caterer should provide quality food and service on time. The service should be provided smoothly and in a professional manner within the prescribed time and place communicated by the institute. The caterer shall not subcontract to another person/business.
- vi) The Commercial bids of only those bidders who qualify the technical evaluation stage will be opened. All other Commercial bids will be returned unopened. The Commercial Bids (As per the formats provided in the RFP Document) of the technically qualified bidders will be evaluated as per the evolution criteria mentioned in this document.
- vii) On the financial bids opened, the bidder with the lowest financial quote in each category shall be considered as L1, All the other technically qualified bidders will have to match their financials with the lowest rate (L1) for empanelment. It shall be obligatory on the part of the empaneled bidders to match the lower rate (L1) in each category.

All the technically qualified agencies agreeing to match the aforementioned prices shall be viii) empaneled. The Client of RIMS, Imphal, shall award the catering service to any of the empaneled consulting firms at the "Value" and for the Scope of Work" as finalized under their RFP.

- Merely quoting of lowest price does not entail the bidder for award of the contract. The ix) price should be justified in accordance with the prevailing market rate, quality of service in question and as such the Tender Committee's decision shall be binding on the bidders. Unrealistic rates/ quotation shall be rejected outrightly.
- Any revision in rates will be considered only at the time of renewal of the contract by X) mutual agreement taking into consideration the market/inflation rates.
- No money will be given by the Institute as advance; payment will be made after submission xi) of the bill. All the payments will be made in Account Payee Cheques/TSA only in favour of the service provider.
- The caterer should keep in mind the unit cost/ per head cost as instructed by the institute xii) while providing foods to the guests/ staffs/ students, in case any deviation beyond the per head cost the agency should seek the consent of the responsible officials of the Institute.
- The agency is not supposed to claim/demand any money from the faculty/ guest/ students/ xiii) participants for providing the service. However, if any extra service beyond the institute prescribed service the agency should provide the same if available with them provider prior consent of the responsible officer of the institute.
- The institute reserves the right to empanel the service provider at its discretion. The xiv) Institute has reserved/ right to cancel the EOI at any stages of all tenders. The Institute reserves the right to change any condition of the EOI before opening of the technical bids.
- Canvassing in any form will make the tender liable to rejection. Conditional tender will not XV) be accepted and will be rejected outright.
- The tenderer should have certificate and possess license as per Food safety and standards xvi) & FSSAI Act 2006 (Attested copies of the certificates to be submitted along with technical bid).
- The bidder should have a valid license issued by the Competent Authority. Duly signed xvii) copy of catering license should be enclosed with the technical bid.
