CIRCULAR

No.GEN/MISC/66/2025-CAO/FA: In an effort to streamline and regulate the use of gym equipment and related facilities at the Gymkhana of RIMS, Imphal, the following guidelines are issued for information and compliance:-

- i) <u>Eligibility</u>: All Students, RIMSONIANs, Employees and their dependents of RIMS, Imphal, are eligible to use the Gym facilities available in Gymkhana of RIMS, Imphal.
- ii) <u>Submission of Enrolment Forms</u>: It will be mandatory to enroll/register as members of the Gymkhana, before availing the Gym facilities. Accordingly, all eligible individual, intending to use the Gymkhana facilities, are required to submit duly completed Enrolment forms (<u>ANNEXURE I</u>) to the Office of the Director on or before 20th September, 2025. In case of enrolment for dependents of employees, a separate Registration form (<u>ANNEXURE II</u>) is enclosed.
- 2. From $\mathbf{1}^{\mathsf{st}}$ October, 2025, entry to the Gymkhana will be permitted based on the following:-
 - Undergraduate (UG) and Postgraduate (PG) Students:
 will be permitted entry upon presenting their valid RIMS IDs.
 - All Other Categories of Users:
 Entry will be permitted strictly upon production of a valid Gymkhana
 Entry Pass, which will be issued after successful enrolment and payment of requisite Fees.
- 3. Accordingly, all eligible individuals are requested to follow these guidelines to help the Gymkhana run smoothly, safely, and efficiently.
- 4. This Circular is issued with the approval of the Director, RIMS, Imphal.
