All candidates are required to report by 8:30 AM with original documents.

Candidates are instructed to log in followed by their roll number, without any gap. Candidates who are unable to attend the counselling in either mode may appoint a representative. Availability of Seats for Second Round of Counselling

- RIMS Graduate Open Category: 4 seats (SC: 1, EWS: 1, UR: 2)
- Non-RIMS Graduate Open Category: 1 seat (UR: 1)
- In-Service Sponsored Category: 61 seats

Reservation breakup:SC: 15% (9 seats);ST: 7.5%(4 seats);OBC: 27%(16 seats);EWS: 10%(6 seats),UR-26 seats.

All candidates applying under the reserved categories must submit valid category certificates as specified in the NEET-PG 2025 Admit Card at the time of admission. The In-Service Sponsored Category shall be treated as a single consolidated pool, and seat allocation within this pool shall be carried out strictly in accordance with the reservation norms mandated under the Central Educational Institutions (Reservation in Admission) Act.
