No. HGEN/HS/PMJY/1/2025 O/o MS: There are many allegations and complaints that the empanelled Pharmacies under PMJAY, RIMS are charging extra money from PMJAY beneficiaries over and above the approved package rates under PMJAY schemes.

- It is also given in Sl. No. 1 and Sl. No. 7 of this office order no. CMHT-RIMS/RKS/0001/1219 dated  $16^{th}$  December, 2019 in the Terms and Conditions to be followed by the empanelled pharmacies that  ${\it ``The'}$ empanelled chemist shop/Pharmacy shall be required to sell medicines and consumable items to the CMHT/PMJAY beneficiaries without charging any money and a minimum of atleast 10% discount shall be given on sale of medicines" and "No any cash/top-up shall be claimed from the patient party during treatment period i.e. from the time of admission till the date of discharge from the Hospital" respectively.
- This is a serious violation of the PMJAY zero out-of-pocket expenditure for treatments covered under the PM-JAY by the empanelled Pharmacies.
- 4. All empanelled Pharmacies of PMJAY, RIMS are warned that they should comply with the PM-JAY guidelines and non-compliance will be viewed seriously.
- Ceiling of price of commonly used drugs was also published.
- The Nodal Officer of PMJAY, Pharmacist and Incharge of PMJAY, RIMS should ensure that prescriptions and cash memos are thoroughly checked to prevent any instances of overcharging.
