Accordingly, all existing Associations/Unions of RIMS, Imphal, are hereby directed to submit a fresh application, on or before Wednesday, the 31st July, 2024, along with the following documents, duly signed by their respective office bearers, for being considered by Competent Authority, for renewal of recognition:-

- a) Memorandum of Association (MOA);
- b) Constitution / Bye-laws of the Association;
- c) Names of Office-bearers of the Associations along with their designations.
- d) A list of members of the Associations/Unions and
- e) Audited statement of accounts of the Service Association/Union.
- 2. The new Association/Union/Groups of employees of Regional Institute of Medical Sciences, Imphal, who wish to seek recognition under the CCS (Recognition of Service Association) Rules, 1993, are invited to submit their applications enclosing the aforementioned documents, for being considered by the Competent Authority, for recognition to the Office of the Director, RIMS, Imphal, within the aforementioned time limit.
- 3. Constitution / Bye-laws of the Association must be in conformity with the CCS (Recognition of Service Associations) Rules, 1993.
