 iGOT Karmayogi portal –reg.

No. GEN/IGOT/1/2025-ESTSec: In continuation of this Office Memorandum of even number dated 04/09/2025 (Copy enclosed), notifying the Mandatory Courses and Comprehensive Assessment in the iGOT portal, which are to be completed by the 31st March, 2026, it is hereby informed that in order to enable regular Employees belonging to MTS and equivalent posts (Pay Level 1-3) to complete the six mandatory Courses, the Ministry has approved alternative Courses, which can be consumed by them in *lieu* of the mandatory Courses in Hindi Language.

2 . Accordingly, the Ministry has permitted these employees to consume the English Version of the Course "Code of Conduct for Government Employees" instead of "Do's and Don'ts for Government Employees (Hindi)". The rest of the 5 Mandatory Courses notified earlier, remains the same.

3. The Courses for all the other Pay Levels, as notified earlier, remain the same.

4. Further, all regular employees are once again reminded that they will be required to consume the 6 Mandatory Courses, which are linked to their APAR and are also already reflected in their Dashboard. They are also required to appear for the Comprehensive Assessment Examination on their Dashboard **from October, 2025 till 31st March 2026.**
