Subject: Mandatory registration of regular Employees on the iGOT
Karmayogi portal - reg.

No.GEN/IGOT/1/2025-EST Sec: In continuation to this Institute's Circular of even number dated 14/08/2025, on the above-mentioned subject, it is informed that there are still around 150 regular employees, who are yet to get themselves registered on the iGOT Karmayogi Portal, even after the expiry of the deadlines given earlier, the last deadline being, 20.08.2025.

2. As notified earlier registration on iGOT portal is mandatory and hence those employees are once again given a final opportunity to register themselves/complete their registration and profile updation on the iGOT Karmayogi Portal. It is once again reminded that if any regular employee fails to register on the iGOT portal, their APAR will be affected, which will also affect other service matters like MACP, Promotion, Deputation etc. They will not only face difficulties in the future, but will also be liable for Administrative action, in case of non-compliance to this exercise.

3. Regular employees, who have not yet registered on the iGOT portal, are directed to complete their registration process at the earliest, and in any case, by Saturday, the 23rd August, 2025. For employees having difficulties in the registration process, a special camp will be conducted on Friday and Saturday, the 22nd and 23rd August, 2025, in the I.T. Section, RIMS, Imphal, as a last opportunity.
