CONTRACT TO BE EXECUTED BY MD/MS STUDENTS (OPEN, RIMS-AIQ, NON-RIMS & AIQ CATEGORIES)

A. By This CONTRACT, I Mr/Mrs/Miss

S/O, D/O, W/Oresident of
(Hereinafter called "the Obligator") at present admitted in Regional Institute of Medical
Sciences, Imphal (RIMS) and (1) Shri/Smt(2) Shri/Smt
(Hereinafter called the Sureties) do hereby bind ourselves and our
respective heirs, executor, administrators and representatives jointly, severally and
respectively to pay to the Director, Regional Institute of Medical Sciences, Imphal
(hereinafter called "the RIMS Authority" which expression shall include its successors and
assignees) on demand to pay a definite sum of amount whichever is applicable as described
in Para B (1-4) of this contract towards failure to fulfil the obligation/for violation of the
condition here-in-after mentioned.
B. AND WHEREAS the Obligator and the Sureties have agreed to execute this contract with such conditions as hereunder written:
1. Now the condition of the above written obligation is that at the time of admission into the
MD/MS Courses at RIMS, the obligator has surrendered the original documents, i.e.
Permanent Medical Registration Certificate, Mark Sheets of 1st Professional, 2nd
Professional & 3rd Professional MBBS (Part I & II), MBBS Degree Certificates and in the
event of the obligator Dr fails to join duty or
resigns or quits the Post Graduate Course before completion of one academic year of the said
course, the Obligator and Sureties shall forthwith pay severally or jointly to the RIMS
authority on demand a sum of ₹ 3,00,000/- (Rupees three lakhs) only for withdrawing the

said original documents.

- 2. AND WHEREAS the said obligator, after joining the MD/MS course, leaves, resigns or quits the said Post Graduate course after completion of one academic year from the date of admission, the Obligator and the Sureties shall forthwith pay severally or jointly to the RIMS authority a sum of ₹ 7,00,000/- (Rupees seven lakhs) only for withdrawing the original documents.
- 3. AND WHEREAS the said obligator shall also return the cumulated stipend received from RIMS before quitting the MD/MS course. However, a full waiver of the above mentioned amount may be granted by the RIMS authority in case of grave illness/severe disability necessitating withdrawal from the college or on death of the PG student on the basis of individual cases.
- 4. AND WHEREAS the said obligator, on admission shall serve the Institute as Senior Resident for a period of 1 (one) year after successful completion of the course and in the event of default, the Obligator and Sureties shall pay forthwith a sum of ₹ 20,00,000/-(Rupees twenty lakhs) only severally or jointly to the Institute.
- C. AND WHEREAS the said obligator, after successful completion of the course shall not pursue fresh higher studies, appear in interviews, accept offers of any regular/contract appointments, etc. within the period of 1 (one) year without the prior approval of the competent authority, failing which, the Obligator and Sureties shall pay forthwith a sum of \ge 20,00,000/-(Rupees twenty lakks) only severally or jointly to the Institute.
- D. AND WHEREAS the said obligator, with prior permission from the competent authority to appear the NEET SS or equivalent examination and if selected for higher studies, shall have to undergo a minimum of 3 (three) months of the mandatory Senior Residency before releasing from the Institute for further studies, failing which, the Obligator and Sureties shall pay forthwith a sum of $\stackrel{?}{\underset{?}{$\sim}}$ 20,00,000/- (Rupees twenty lakhs) only severally or jointly to the Institute.
- E. The contract is legally binding on the Obligator and the Sureties and upon the payment of such sum the above written obligation shall be void and of no effect, otherwise this shall remain in full force and effect.
- F. This contract shall in all respects be governed by the laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts with its jurisdiction in Manipur.
