- 5. Provisional Pass Certificate and Manipur Medical Council Registration or any proof of applying for Registration to MMC.

While applying, the following points may be noted.

- : First preference will be given to the fresh RIMS pass out candidates and Second preference will go to RIMS pass outs who have completed 6 months of Junior Residency
- : Third preference will be given to fresh candidates from other Colleges.
- : No candidates who have completed 1 year after internship will be considered.
- : Selection will be done by assessing the marks obtained in MBBS examination, Number of attempts and performance in the interview.
- : Once selected, no unauthorized absence will be permitted and private practice is not allowed.
- : The authority reserves the right to appoint an applicant as J.R. in any Department as per the need of the Hospital.
