State governments will nominate selected candidates to RIMS at the earliest.

Nominees must accept and complete admission formalities at RIMS within the scheduled dates which will be notified later.

Re-allocation of Vacant Seats:

If a beneficiary state does *not* nominate candidates by the deadline, vacant seats will be automatically opened to the host state.
