No. B/3025/2015-RIMS: With reference to this Institute's Advertisement dated 16.01.2016 for appointment of Multi Tasking Staff (MTS), RIMS, Imphal, it is hereby notified that this institute will conduct Written Examination of MTS on 12.11.2023 at Imphal & Guwahati to fill up the vacant posts of MTS in respect of the revised reservation norms i.e. SC-04, ST-46, OBC-17 & UR-64.

2. Candidates in the attached list must choose the examination centre in which he/ she desires to take the examination i.e. Imphal or Guwahati. For this, the candidate must visit RIMS website: [www.rims.edu.in](http://www.rims.edu.in) and he/she must click in the link given in the website and follow the instruction therein on or before 20.10.2023 (12:00 p.m.). In case of any problem, the candidate may visit at Jubilee hall, RIMS, Imphal from 10.10.2023 to 20.10.2023 during office hours (10:30 am to 4:30 pm) along with earlier Admit Card issued by this institute & one recent passport photograph of themselves or e-mail to [rims.imphal@gov.in](mailto:rims.imphal@gov.in). In any case, the examination centre once opted cannot be changed.

3. A fresh admit card & new roll number will be issued only to those candidates who opted the examination centre (Imphal or Guwahati) for appearing the Written Examination of MTS and the earlier Roll number & admit card issued to candidates stands cancelled.

4. No candidate can choose their preferred examination centre after 20.10.2023 (24:00 hrs) in any case and any objection/representation received after 4:30 p.m. of 21.10.2023 will not be entertained.
